**TITLE: REHABILITATION OF THE WATER SUPPLY SYSTEM IN MITROVICA SOUTH,
VUSHTRRI AND SKENDERAJ, INVESTMENT STAGE 2 PART 1**

*in the framework of Project KSV/018 receiving financial support from the Governments of the Grand Duchy of
Luxembourg and the Republic of Kosovo*

This notice of invitation is launched by the Luxembourg Agency for Development Cooperation, (Lux-Development) on behalf of Project KSV/018 – Water in Mitrovica (Phase II) - receiving financial support from the Governments of the Republic of Kosovo and of the Grand Duchy of Luxembourg.

1) IDENTIFICATION AND FINANCING OF THE PROJECT

- a) **Title:** KSV/018 - Water in Mitrovica (Phase II)
- b) **Reference number:** KSV/018•15 434
- c) **Source of financing:** The Government of the Republic of Kosovo and the Government of the Grand Duchy of Luxembourg, as well as the respective participating Municipalities, as set out in the project's KSV/018 Bilateral Agreement.
- d) **Status of financing:** *The tender procedure is issued before the project office of KSV/018 is legally established in Kosovo – which will be done following the ratification of the Bilateral Agreement in the Kosovo Parliament. Therefore, the award of the contract shall include a suspensive clause – conditional on: (1) the complete registration of the project office in Kosovo, i.e. following the date of receipt of the VAT Exemption Certificate for Project KSV/018; and (2) on the payment/receipt of funds on the KSV/018 project account, originating from the financial contributions of the respective Municipalities of Mitrovica South, Vushtrri and Skenderaj, as per the signed Memorandums of Understanding. The second conditionality will be considered for each lot separately.*
