This notice of invitation is launched by the Luxembourg Agency for Development Cooperation (Lux-Development), on behalf of Project MON/005 Cardiovascular Centre, MCH and E-health Expansion, receiving financial support from the Governments of Mongolia and the Grand Duchy of Luxembourg.
