TITLE: Construction of 5 Medium Scale Agricultural Infrastructure Projects (Works)

in the framework of Project VIE/028 receiving financial support from the Governments of the Grand Duchy of Luxembourg and the Socialist Republic of Vietnam

This notice of invitation is launched by the Department of Agriculture and Rural Development of Nghe An Province represented by Project Management Unit, on behalf of Project VIE/028 - Western Nghe An Rural Development Project receiving financial support from the governments of the Socialist Republic of Vietnam and of the Grand Duchy of Luxembourg.

1) Identification and financing of the project

- b) Object: Construction of 5 Medium Scale Agricultural Infrastructure Projects

 - Lot D. Construction of Dormitory of Nghe An Mountainous - Ethnic Minority Vocational Training School.
- d) Grouping of lots: Tenderers must submit separately offer for each lot and can submit offers for one or more lots but can be awarded maximum two lots. If a tenderer participates in more lots, and is evaluated to be the lowest compliant for more lots but with the same team and equipment, he can be awarded only one lot. In any case the choice of the lot(s) to be awarded will be based on the highest margin of corrected tender price between the second place tenderer and the winning tender.

3) Eligibility and evaluation criteria

- b) Eligibility: open to companies satisfying the criteria included in the Statement of Good Standing and in the Ethics clauses of the General Regulations
- c) Evaluation: the lowest administratively and technically compliant tender will be granted the contract
