

NOTICE OF CALL FOR EXPRESSIONS OF INTEREST CVE/083 • 19 1744

Title: Technical Assistant for the Electric Sector Regulation Support Project in Cabo Verde (Package 2: a. Network Access and Interconnection Regulation; b. Dispatch Regulation; c. Regulation applicable to the isolated micro-grid system powered by renewable energies)

Maximum budget: 112,500 EUR – performance period of 10 months

The Luxembourg Agency for Development Cooperation (LuxDev) launches a Call for expressions of interest for the acquisition of services for **Technical Assistant for the Electric Sector Regulation Support Project in Cabo Verde (Package 2)** on behalf of Program CVE/083 receiving financial support from the Governments of the Republic of Cabo Verde and the Grand Duchy of Luxembourg. The specific objective of this consultancy is to elaborate the **Network Access and Interconnection Regulation, Dispatch Regulation** and the **Regulation applicable to the isolated micro-grid system powered by renewable energies**.

Services providers that are invited to express their interest to offer the services mentioned above are all legally established companies governed by private law (excluding non-governmental organisations, not-for-profit organisations and public operators) and specialised in developing electricity sector regulations that are conducive for the technical and economic stability of the energy ecosystem, sustainable participation of private sector in the respective market, and effective consumer protection.

To qualify for this assignment, services providers will have to demonstrate their technical capacity and experience in energy regulation law, track record in the successful implementation of similar projects, and experience in advising governments on regulation activities to strengthen the energy sector's performance.

The start of the contract is foreseen for July 2019 and for a duration of 10 months. Services providers must be available for the entire period foreseen and willing to intervene in Praia – Santiago Island – Cabo Verde. The maximum budget available for this contract is estimated at 112,500 EUR (all taxes excluded).

Interested services providers are invited to submit sufficient documentation to respond to the selection criteria. The dossier, including the selection criteria and the application form is available on request at the address given below.

The shortlist of candidates invited to submit a full offer will be established of minimum three (3) and maximum eight (8) candidates evaluated as qualified and ranked if necessary against the selection criteria.
