

**NOTICE OF INVITATION TO TENDER N° KSV/017•22 5384**

**TITLE: Medical Equipment for the Prizren Hospital – 3 LOTS (Goods)**

*in the framework of Project KSV/017 receiving financial support from the governments  
of the Republic of Kosovo and of the Grand Duchy of Luxembourg*

This notice of invitation is launched by and according to the procedures of the Luxembourg Agency for Development Cooperation (Lux-Development), on behalf of Project KSV/017 receiving financial support from the governments of the Republic of Kosovo and of the Grand Duchy of Luxembourg.

**1. Identification and financing of the Project**

- a) Title: Project KSV/017: Health Support Programme in Kosovo – Phase II
- b) Source of financing: The Government of the Republic of Kosovo and the Government of the Grand Duchy of Luxembourg, as set out in the Project's Bilateral Agreement and Kosovo's Law No. 05/L-059, published in the Official Gazette of the Republic of Kosovo No. 36 / 21 December 2015.
- c) Status of financing: Under consideration<sup>1</sup>

**This tender is launched under a suspensive clause.**

The award of the contract is subject to the fulfilment of the following pre-condition:

- The formalization and signature of extension of the Project KSV/017 Bilateral Agreement between the Government of the Grand Duchy of Luxembourg and Government of the Republic of Kosovo.

Non-fulfilment of the above-mentioned pre-condition will lead to a cancellation of this tender procedure and the termination of the award of the contract.

**2. Identification of the Contract**

- b) Object: Supply, delivery, installation and commissioning of Medical Equipment for the Prizren Hospital

**Lot 1:** Cardiology Equipment (C-ARM angiograph apparatus)

**Lot 2:** Cardiology Equipment

**Lot 3:** Maxillofacial Equipment

- e) Grouping of lots: the combination of lots is possible at the time of award (a tenderer may be awarded several lots). To do so, the tenderer must meet the administrative and technical requirements of the lots.

Note: Tenderers applying for more than one lot may submit a single tender covering these lots, specifying unequivocally in the documents that require it the information specific to each of the lots concerned.

- a) Origin: no restriction
- b) Eligibility: companies satisfying the criteria included in the Statement of Good Standing and in the Ethics Clauses of the General Regulations - please be aware that companies which are not registered in Kosovo may need a local grouping member in order to execute the import or have to register in Kosovo. Project KSV/017 will not be able to support the registration in Kosovo and can in no way be held accountable for delays in the registration process.
- c) Evaluation: the lowest administratively compliant and substantially technically compliant tender will be granted the contract (lot by lot)
- d) Variants: no variants will be considered

These performance periods are non-cumulative in case a tenderer is awarded more than one Lot.
