

NOTICE OF CALL FOR EXPRESSIONS OF INTEREST LAO/027 • 14 646

Title: Acquisition of Services for Construction Supervision of Bolikhamxay Provincial Hospital (Services)

Maximum budget: 125,000 Euros (excluding VAT and taxes)

Performance period of thirty-four (34) calendar months

The Luxembourg Agency for Development Cooperation (LuxDev) launches a Call for expressions of interest for the acquisition of services for Construction Supervision of Bolikhamxay Provincial Hospital on behalf of Project LAO/027 receiving financial support from the Governments of Lao P.D.R. and of the Grand Duchy of Luxembourg.

Services providers that are invited to express their interest to offer the services mentioned above are all legally established companies governed by private law (excluding non governmental organisations, not-for-profit organisations and public operators) and specialised in supervision of construction works, project management.

Indicatively, services providers will have to demonstrate their technical capacity and experience in supervision of construction of health facilities and project management of civil works in existing and operational facilities.

The start of the contract is foreseen for Mid May 2015 and for a duration of thirty-four (34) calendar months, comprising of two stages:

- Stage 1: (22 months) from the commencement of the construction until the provisional acceptance of the works.
- Stage 2: (12 months) defects liability period, from the provisional acceptance until the final acceptance of the works.

Services providers must be available for the entire period foreseen and willing to intervene in Paksane, Bolikhamxay province, LAO PDR.

The maximum budget available for this contract is estimated at 125,000 Euros (excluding VAT and taxes).

Up to twenty-two (22) months (Stage 1): the contract type is a "lump sum" contract (where an all-in price covers the whole of the services which are the subject of the contract shall be made pro rata to the progress of the works completed).

During extension of performance period of the Stage 1 (if required) and during defects liability period (Stage 2): the contract type is a "unit price contract" against submitted daily rates and Time Sheets.

Interested services providers are invited to submit sufficient documentation to respond to the selection criteria. The dossier, including the selection criteria and the application form is available on request at the address given below.

The shortlist of candidates invited to submit a full offer will be established of minimum three (3) and maximum eight (8) candidates evaluated as qualified and ranked if necessary against the selection criteria.
