

NOTICE OF CALL FOR EXPRESSIONS OF INTEREST MAE/023 • 24 7404

**Title: End-user impact studies for MAE/023 co-financed projects
- framework contract -**

Maximum budget: 1 000 000 EUR - Performance period of 24 months
(renewable twice)

The Luxembourg Agency for Development Cooperation (LuxDev) launches a call for expression of interest (CEOI) for the acquisition of services for **End-user impact studies for MAE/023 co-financed projects** on behalf of project MAE/023 receiving financial support from the Grand-Duchy of Luxembourg.

Services providers that are invited to express their interest to offer the services mentioned above should be legally established companies governed by private law, as well as non-governmental organisations and not-for-profit organisations (excluding public operators), as well as specialised in impact studies and user surveys.

Indicatively, services providers will have to demonstrate their technical capacity and experience in impact studies and user surveys in different sectors (such as agriculture/food security, water, education and professional training and digital innovations).

The start of the contract is foreseen for April 2025 for a duration of 24 months, renewable twice if the performance is deemed satisfactory by the contracting authority and according to the effective duration of project MAE/023. Services providers must be available for the entire period foreseen and willing to intervene in the 13 countries where Luxembourg Cooperation is active (among them, Rwanda, Senegal and Kosovo will have the biggest number of projects) or other countries that could be added to LuxDev's portfolio in the coming years. The contract will be multiple-suppliers framework contract with distinct mobilisation requests each validated with a mobilisation order. At the end of the tender procedure and following the evaluation of the offers, a maximum of three tenderers will be invited to sign a framework agreement. Each mobilisation will involve the re-opening of the competition between the selected providers.

The maximum budget available for this contract is estimated at 1 000 000 EUR (all taxes excluded) for the entire contract period, including any possible renewal, divided into several mobilisations on an *ad hoc* basis. This budget represents the maximum estimated amount for all the mobilisations and is subject to mobilisation orders. The contracting authority is not obliged to use the entire budget.

Interested services providers are invited to submit sufficient documentation to respond to the selection criteria. The dossier, including the selection criteria and the application form, is available on request at the address given below.
