

NOTICE OF INVITATION TO TENDER N°: LAO/017 – 12 756

TITLE: Construction of health facilities in Vientiane, Bolikhamxay and Khammouane provinces (Works)

in the framework of Project LAO/017 receiving financial support from the Governments of the Lao PDR and the Grand Duchy of Luxembourg

This Notice of Invitation to Tender is launched by the Ministry of Health on behalf of Project LAO/017 “Health Sector Support Programme” receiving financial support from the Governments of the Lao PDR and of the Grand Duchy of Luxembourg.

Qualified works contractors are invited to submit bids for the construction of Health Centers in Vientiane, Bolikhamxay and Khammouane Provinces in Lao PDR. The construction of these Health Centers is constituted of galvanized steel structure, which is built independently from the ground slab and non load bearing masonry partition walls which they cover. The average size of covered area per unit is two hundred and fifty square meters (250 sqm).

1) Identification of the contract

- a) Type of contract: **Fixed price Lump Sum Contract**
- b) Object: **Construction of Rural and Urban Health Centres in three (3) Provinces**
- c) Number of lots: **five (5)**
 - **Lot 1:** Two (2) Rural Health Centres in Vientiane Province (Muen and Phabong);
 - **Lot 2:** Three (3) Rural Health Centres in Bolikhamxay Province (Nakham, Nateuy and Pakkading);
 - **Lot 3:** Three (3) Rural Health Centres in Khammouane Province (Kayou, Naphao and Phonemeuang).
 - **Lot 4:** One (1) Urban Health Centre in Bolikhamxay Province (Hongxai);
 - **Lot 5:** One (1) Urban Health Centre in Khammouane Province (Namdone);
- d) Grouping of lots: **allowed, subject to the conditions described in the Tender Dossier**

2) Eligibility and evaluation criteria

- a) Origin: **No restriction on origin**
- b) Eligibility: **Open internationally to companies satisfying the criteria included in the Statement of Good Standing and in the Ethics clauses of the General Regulations**
- c) Evaluation: **The lowest administratively and technically compliant tender will be granted the contract**
- d) Variants: **Variants will be considered, subject to the conditions described in the Tender Dossier**

3) Sites and deadlines

- b) Place of performance: **Vientiane, Bolikhamsay and Khammouane Provinces**
- c) Performance period: **seven (7) months** including a mobilisation period of one (1) month)
- d) Validity period of tenders: **90 days from the deadline for receipt of tenders**
