

NOTICE OF INVITATION TO TENDER N°: LAO/017•12 358

TITLE: Medical goods for Health Facilities (Goods)

in the framework of Project LAO/017 receiving financial support from the Governments of the Grand Duchy of Luxembourg and Lao PDR

This notice of invitation is launched by the Luxembourg Agency for Development Cooperation (Lux-Development) on behalf of Project LAO/017 "Lao-Luxembourg Health Sector Support Programme" receiving financial support from the Governments of Lao PDR and of the Grand Duchy of Luxembourg.

1) Identification and financing of the Project

- b) Object: **Medical goods for Health Facilities**

 - Lot 4: Medical Equipment Imaging
 - Lot 5: Medical Equipment Sterilization & Laundry
 - Lot 6: Medical Supplies
 - Lot 7: Medical Instrumentation
 - Lot 8: Medical Furniture

Grouping of lots: The present tender dossier consists of 8 (eight) distinct lots. Tenderers can submit tenders for one or several lots and be awarded one or several lots. To be awarded several lots, a tenderer must demonstrate an average annual turnover of 1.5 times the financial amount of the lots that may be awarded to him.

3) Eligibility and evaluation criteria

- a) Origin: no restriction
- b) Eligibility: companies satisfying the criteria included in the Statement of Good Standing and in the Ethics clauses of the General Regulations
- c) Evaluation: the award of contracts will be made lot by lot to the lowest administratively and substantially technically compliant tender and in the overall interest of the Project.
- d) Variants: no variants will be considered
