

**NOTICE OF INVITATION TO TENDER N°: LAO/017 – 12 312**

**TITLE: Construction of District Hospital in Pakkading, in Bolikhamsay Province  
(Works)**

in the framework of Project LAO/017 receiving financial support from the Governments of  
the Lao PDR and the Grand Duchy of Luxembourg

This Notice of Invitation to Tender is launched by the Ministry of Health on behalf of Project LAO/017 “Health Sector Support Programme” receiving financial support from the Governments of the Lao PDR and of the Grand Duchy of Luxembourg.

Qualified works contractors are invited to submit bids for the construction of a District Hospital in Pakkading, Bolikhamsay Province, Lao PDR. The construction of this District Hospital is constituted of prefabricated galvanised steel structure, which is built independantly from the ground slab and non load bearing masonry partition walls which it covers.

Potential bidders will have, among other things, to demonstrate their financial capacity as well as previous experience in construction involving galvanised steel structures and masonry walls in similar type and size of buildings.

**1) Identification of the contract**

- b) Object: **Construction of one (1) District Hospital in Pakkading, in Bolikhamsay Province** (covered area : two thousand one hundred and sixty square meters (2,160 sqm))

**2) Eligibility and evaluation criteria**

- b) Eligibility: **Open internationally to companies satisfying the criteria included in the Statement of Good Standing and in the Ethics clauses of the General Regulations**
- c) Evaluation: **The lowest administratively and technically compliant tender will be granted the contract**
- d) Variants: **Variants will be considered, subject to the conditions described in the Tender Dossier**
