The solar photovoltaic car park roof for Thua Thien Hue Department of Planning and Investment (DPI) has an area of 189m², and can accommodate 10 cars which is designed to produce 25KWp of electricity. The system of PV car roof includes:

- One car roof of 189m² covered by 159 solar panel cells;
- 3-phases electricity current inverter ;
- 48 inch indoor flat 4K smart LED ultra clear display panel including PV telemetry. A double 48 inch outdoor flat full HD smart LED display including dual PV.
- 1680m solar panels brushing robot, PP roller nylon bristle cleaner.
