This notice of invitation is launched by the Luxembourg Agency for Development Cooperation (LuxDev), on behalf of project LAO/027 Lao-Luxembourg Health Sector Support Programme – Phase II receiving financial support from the governments of Lao P.D.R. and of the Grand Duchy of Luxembourg.

#### 1) Identification and financing of the project

#### 2) Identification of the contract

- a) Type of contract: Goods
- b) Object: Supply of medical equipment for Bolikhamxay provincial hospital
- c) Number de lots: 9 (nine) lots, each lot being indivisible. Lots are:
  - Lot 1: Dental
  - Lot 2: Diagnostics, monitoring and treatment
  - Lot 3: Imaging
  - Lot 4: Laboratory
  - Lot 5: Obstetrics
  - Lot 6: Ophthalmology
  - Lot 7: Physiotherapy and traditional medicine
  - Lot 8: Sterilisation and medical waste treatment
  - Lot 9: Surgical
- d) Grouping of lots: The present tender dossier consists of 9 (nine) distinct lots. Tenderers can submit tenders for one or several lots and be awarded one or several lots. To be awarded several lots, a tenderer must demonstrate an average annual turnover of 1.5 times the financial amount of the lots that may be awarded to him.

#### 3) Eligibility and evaluation criteria

- b) Eligibility: companies satisfying the criteria included in the Statement of Good Standing and in the Ethics clauses of the General Regulations
- c) Evaluation: the lowest administratively compliant and substantially technically compliant tender will be granted the contract
- d) Variants: no variants will be considered
