

NOTICE OF CALL FOR EXPRESSIONS OF INTEREST N° CVE/390•25 8495

Title: Consulting services for the preparation of the Abbreviated Compensation Plan or Livelihood Restoration Plan in the areas of implementation of the Pumped Hydro Energy Storage Plant (PSP) project on Santiago Island

Maximum budget: 75 000 EUR - Performance period of 12 months

LuxDev, the Luxembourg Development Cooperation Agency launches a Call for Expression of Interest (CEOI) for the acquisition of services for **Consulting services for the preparation of the Abbreviated Compensation Plan (*Plano Abreviado de Compensação – PAC*, in portuguese) or Livelihood Restoration Plan (*Plano de Restabelecimento de Meios De Subsistência*, in portuguese) in the areas of implementation of the Pumped Hydro Energy Storage Plant (PSP) project on Santiago Island** on behalf of programme CVE/390 receiving financial support from the governments of the Republic of Cabo Verde and the Grand-Duchy of Luxembourg.

Economic operators that are invited to express their interest to offer the services mentioned above are specialised in the preparation of Abbreviated Compensation Plan or Livelihood Restoration Plan (*Plano De Restabelecimento de Meios De Subsistência*, in portuguese).

Indicatively, economic operators will have to demonstrate their technical capacity and experience in given institutional support to the DGPCP and INGT (or any other Cabo Verde state owned entity) in monitoring the expropriation and compensation process to landowners covered by the project and compensation to users of land parcels on which family income depends.

The start of the contract is foreseen for March 2026 and for a duration of 12 months. Economic operators must be available for the entire period foreseen and willing to intervene in Santiago Island, Cabo Verde. The maximum budget available for this contract is estimated at 75 000 EUR (all taxes excluded).

Interested economic operators are invited to submit sufficient documentation to respond to the selection criteria. The dossier, including the selection criteria and the application form, is available on request at the address given below.
