Title: Renovation of three District Hospitals and a Medical Training Unit in Bokeo Province (works)

In the framework of programme LAO/035 receiving financial support from the governments of the Grand Duchy of Luxembourg and the Lao PDR

This notice of invitation is launched by and according to the procedures of LuxDev, Luxembourg agency for development and Cooperation, on behalf of programme LAO/035 receiving financial support from the governments of the Lao PDR and of the Grand Duchy of Luxembourg.

1. IDENTIFICATION AND FINANCING OF THE PROJECT/PROGRAMME
