This notice of invitation is launched by and according to the procedures of LuxDev, the Luxembourg Development Cooperation Agency, on behalf of programme LAO/037 receiving financial support from the governments of the Grand Duchy of Luxembourg and Lao PDR.

1. IDENTIFICATION OF THE CONTRACT

- a) Type of contract: Works
- b) Object: Renovation of 10 Legal Aid Offices in Bolikhamxay and Vientiane Province

2. ELIGIBILITY AND EVALUATION CRITERIA

- a) Origin: No restriction
- b) Eligibility: Economic operators satisfying the criteria included in the statement of good standing and in the ethics clauses of the general regulations.
- c) Evaluation: The most economically advantageous tender on the basis of price will be granted the contract.
- d) Variants: No variants will be considered.

- a) Location of the programme: Vientiane Capital
- b) Place of performance of the contract:

Lot 1: Vientiane province (Hinherb District Legal Aid Office, Kasi District Legal Aid Office and Mad District Legal Aid Office)

Lot 2: Bolikhamxay province (Thaphabath District Legal Aid Office, Paksan District Legal Aid Office, Bolikhan District Legal Aid Office, Pakkading District Legal Aid Office, Khamkeuth District Legal Aid Office, Viengthong District Legal Aid Office and Xaychamphone District Legal Aid Office).
